



## TERMS & CONDITIONS OF LOAN HORSES

1. The horse must not be sold, hired out or loaned at any time to persons other than the agreed borrower, or used for any commercial purposes without the consent in writing of HRH.
2. The horse must not under any circumstances be used for breeding purposes.
3. The horse must not be used for any form of racing, driving or endurance without the written permission of HRH.
4. In cases of illness or injury where veterinary intervention is required, a qualified veterinary surgeon must be called and any advice strictly followed. All veterinary costs incurred will be the responsibility of the borrower.
5. Vaccinations for tetanus and flu (if required) must be kept up to date and the costs incurred will be the responsibility of the borrower.
6. If for any reason humane destruction becomes or appears to be necessary, HRH must be notified immediately. If emergency euthanasia takes place a veterinary certificate must be produced promptly.
7. If the equine is at an age or where health or disability compromise its quality of life, you agree to have the horse humanely euthanized with the knowledge of HRH.
8. Third Party/Public Liability insurance up to £3million is a mandatory requirement, and it is strongly advised that insurance for the following is implemented:
  - Cover for the loss of your horse by theft or straying
  - Protection in the event of the horse's death
  - Up to £5,000 in vet fees per condition
  - Permanent Loss of Use
  - Personal Accident
  - Saddlery and Tack
  - Disposal
  - Cover for trailers and horse-drawn vehicles
9. Written permission and approval must be sought before any change of the horse's location.
10. As a borrower you will be required to meet the cost of transporting the horse both from and to HRH.
11. Should the horse stray or become lost or missing HRH and the police will be immediately notified.
12. Neither HRH nor its officials, trustees or members will be held responsible for any accident, injury or damage caused by the horse, or resulting from its use whilst in your care. As the borrower you will indemnify HRH against any action, claim or award for damage brought or obtained by any person or persons.



13. Re-possession of the horse without hindrance or obstruction by HRH shall be allowed at any time should it be deemed to be in the best interests of the horse.
14. All paperwork, equipment and any other associated items provided with the horse remain the property of HRH, and must be returned with the horse if required or requested in any of the above terms are breached.

### **Donation fees in respect of loan agreement**

#### **COMPANION HORSES**

£150 **administration fee** payable at the time of agreement and **non-refundable**

Monthly donation £5\*\* per month

#### **RIDING HORSES**

Between £150 - £900. Payable before horse is rehomed.

**Includes £150 administration fee** payable at the time of agreement and **non-refundable**

The balance will be retained for a period of **14 days, following which it will not be refundable** and will be utilised for general charitable purposes.

Minimum monthly charitable donation for riding horses from £12\*\*

\*\*The monthly donations can be paid by direct debit or standing order for the duration of the loan agreement
